

Group II does not include the inventive concept of a method of implementing inspection checklists for materials handling vehicles as required by Group I.
	Groups I and II share the technical feature of a materials handling vehicle. However, this shared technical feature is well known and does not represent a contribution over the prior art of US3,246,008 A to McMullen (15 March 1996), which teaches a material handling vehicle (TTitle and Fig 1-14). As the above materials handling vehicle was well known at the time, as evidenced by the teaching of McMullen, this cannot be considered a special technical feature that would otherwise unify the groups.
	Groups I and II therefore lack unity under PCT Rule 13 because they do not share a same or corresponding special technical feature.
