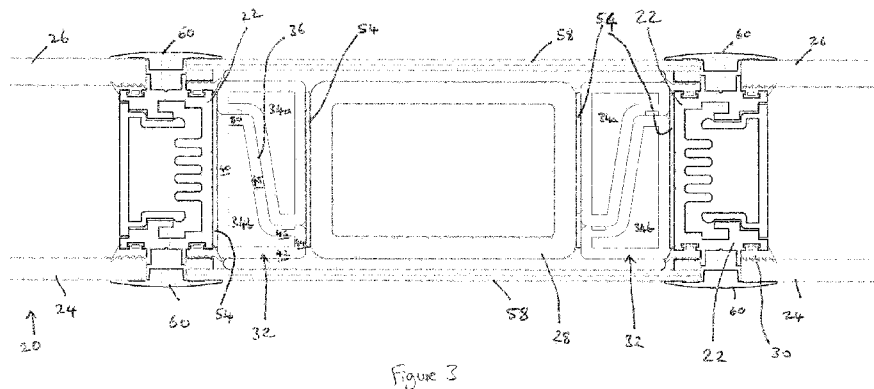

(57) Abstract: A glazing system for an acute care facility, said glazing system comprising at least one glazing panel located between spaced apart support members, at least one spacer member being located between at least one of said support members and an adjacent face of said at least one glazing panel, said spacer member comprising a first part attachable to a said support member and a second part attachable to said adjacent face of said at least one glazing panel, said first and second parts having opposite wedge shaped abutting faces whereby said spacer member places a compressive loading on the glazing panel as the two parts of the spacer member are moved laterally with respect to one another to form an airtight seal between the support member and the glazing panel.
