



(57) Abstract: Medical needle assemblies and needle covers for medical needles are disclosed. The needle covers include a relatively rigid outer surface and more resilient inner surface. The needle covers protect the needle from damage, allow for effective sterilization of the assembly, provide a sterile barrier, and evidence of product tampering.
