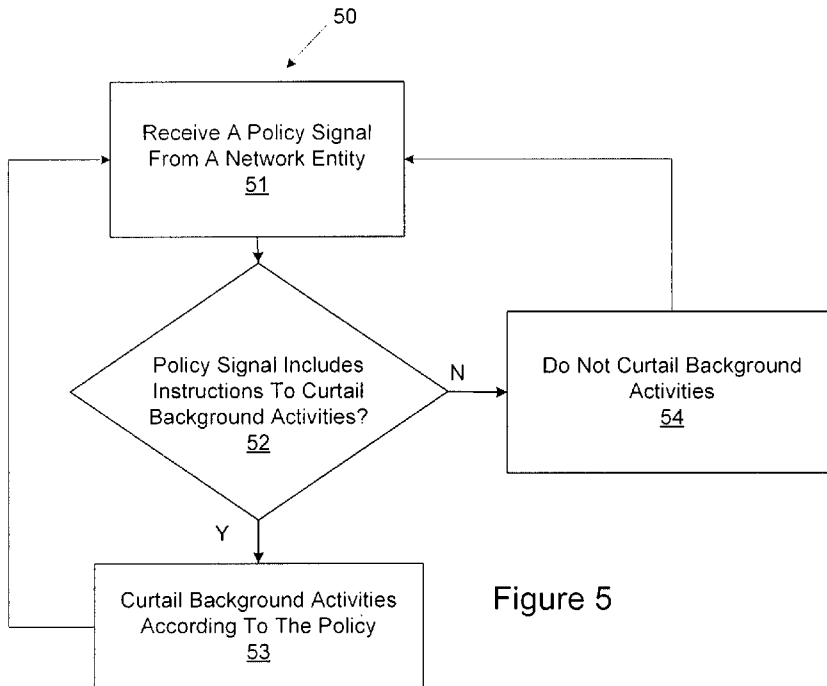

(57) Abstract: A wireless terminal configured to communicate with a network entity other than the wireless terminal in a wireless telecommunications network for the network entity to control background activities of the wireless terminal includes a receiver configured to receive a background activity policy signal including data corresponding to instructions to the wireless terminal to curtail background activities, and a background activity policy controller configured to curtail background activities of the wireless terminal based on the background activity policy signal.
