

(57) Abstract: A method for conducting an e-mail campaign is provided. The method includes the steps of: (a) sending e-mails to a plurality of intended recipients; (b) determining a number of the e-mails that have been indicated as nondeliverable; (c) determining a number of the e-mails that have been identified as bulk and not delivered to the intended recipients; (d) determining, from the determinations made in steps (b) and (c), a number of the e-mails that have reached the intended recipients; and (e) billing only for the number of e-mails determined in step (d).
