(54) METHODS OF TREATING INTRAOCULAR PRESSURE WITH ACTIVATORS OF TIE-2

associated with angiogenesis, for example, intraocular pressure, ocular hypertension, and glaucoma.

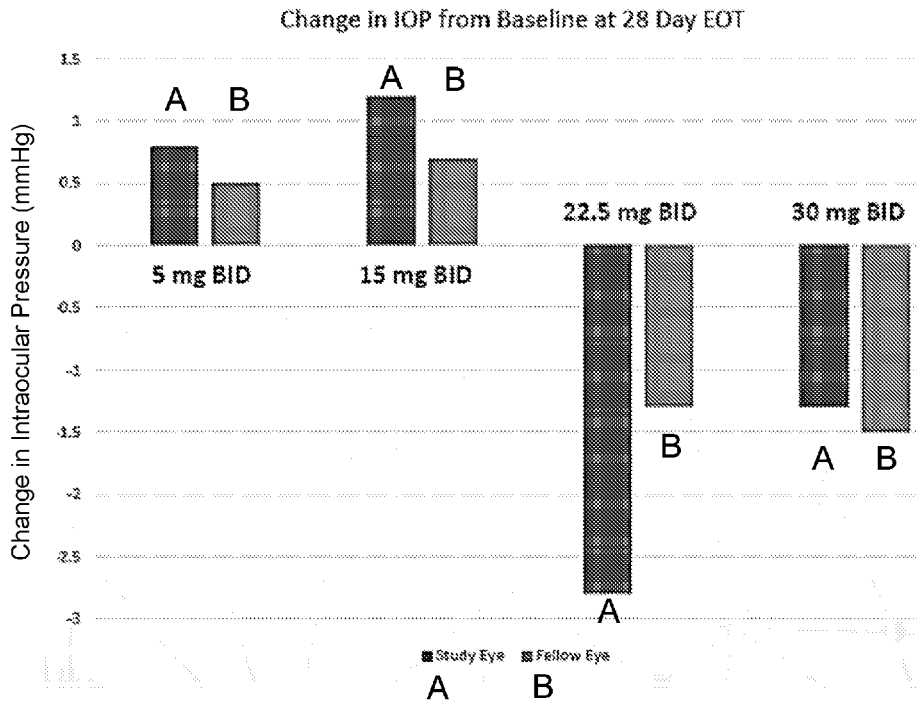
